APPROVING MAP OF RANCHO CARMEL UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by ROBERT C. HAYNES, a Registered Civil Engineer, entitled "RANCHO CARMEL UNIT NO. 2 Being a subdivision of a portion of Pompeii Farms Co., Pompeii Subdivision, according to Map thereof No. 1738, filed September 19, 1922. Revoked per City Council Resolution No. 203923, adopted October 12, 1971, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted, and said Council hereby accepts on behalf of the public, the following: Avenida Del Negocio, Avenida Del Correo, Camino Bancario, Calle De La Fabrica, a portion of Carmel Mountain Road and a portion of Avenida Rancho Carmel for public purposes, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' right of access in and to S.A. 680, adjacent and contiguous to Lots 5, 6, 8, 9 and Parcel A; in and to Carmel Mountain Road, adjacent and contiguous to Lots 3, 4 5 and Parcel

A; and in and to Avenida Rancho Carmel, adjacent and contiguous to Lots 1, 2, 3 and 29, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
