BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the acceptance by the City Manager of that deed of BARRY G. HON, DBA HON DEVELOPMENT COMPANY, executed in favor of The City of San Diego, bearing date of December 1, 1981, conveying to said City an access road easement in Lot 3 of Scripps Mesa Vista, Map No. 9673, as more particularly described in said deed, is hereby approved. Document No. RR- 256279 - 1.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 256279 - 2, quitclaiming to BARRY G. HON, DBA HON DEVELOPMENT COMPANY, all of the City's right, title and interest in the access road easement in Lot 3 of Scripps Mesa Vista, Map No. 9673, as more particularly described in said deed.
