WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the acceptance by the City Manager of that deed of ROBERT Q. SUTHERLAND and R. KENT SUTHERLAND, executed in favor of The City of San Diego, bearing date of February 20, 1980, conveying to said City a drainage easement in Lots 6 and 7 of Starlight Subdivision, Map 8908, as more particularly described in said deed, is hereby approved. Document No. RR- 256280 - /

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 256280 - 2, quitclaiming to ROBERT Q. SUTHERLAND and R. KENT SUTHERLAND all of the City's right, title and interest in the drainage easement in Lots 6 and 7 of Starlight Subdivision, Map 8908, as more particularly described in said deed.

3. That the City Clerk shall cause a certified copy of this resolution, with deeds, attested by him under seal, to be recorded in the office of the County Recorder.
