
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the amount of funds authorized by the City Council in Resolution No. 222320 be and is hereby reduced to \$59,446 thereby deobligating the remaining \$104,554.00.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute for and on behalf of The City of San Diego, an agreement with RICK ENGINEERING COMPANY, to provide professional engineering services in connection with the improvement of Otay Mesa Road, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-256286.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$125,000 from CIP 52-140, Otay Mesa Road-Harvest Road 1.3 miles east of Interstate 805 to the International Border, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
