


RESOLUTION No. R- 256296 (R- 82-1721)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$2,165,194.00 by D & H PERRY INC., dba PERRY ELECTRIC, a corporation for the INSTALLATION OF MASTER TRAFFIC CONTROL SYSTEM CENTRAL BUSINESS DISTRICT in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk.
2. That the City Auditor and Comptroller is hereby authorized to increase the FY 1982 Capital Improvements Program, Capital Outlay Fund 30245, CIP No. 62-052, Central Business District Master Traffic Signal Control System by \$190,000.00.
3. That the expenditure, not to exceed \$2,248,663.00 from Capital Outlay Fund 30245, CIP No. 62-052, Central Business District Master Traffic Signal Control System is hereby authorized for the purpose of executing this contract and related costs.
