That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

| Ernest C. Salgado | Police | \$ 2,500 | Mr. Salgado is a Police Officer. One year ago he earned a partial award of \$2,500 for his suggestion to add a stolen/missing item report to the Police crime reports. One year's experience has shown a savings of \$45,285. This is the remainder of his award. |
| Richard J. Hunt | Water Utilities | \$ 2,455 | Mr. Hunt is a Principal Engineering Aide in the Utilities Services Division. One year ago he earned a partial award of \$295 for his suggestion to have the Water Utilities plan checkers verify Fire Service requirements have been paid for prior to building plans being approved. One year's experience has shown a savings of \$ 9,171. This is the remainder of his award. |
| Robert C. Hauptman | General Services | \$ 1,500 | Mr. Hauptman is a Refrigeration Mechanic in the Buildings Division. He suggested that pressure sensing switches with manual resets be installed on City air conditioning units. In the first year of use this idea saved \$4,338 in labor, equipment and material costs. |
| David E. Maudlin | General Services | \$ 965 | Mr. Maudlin is a Welder in the Equipment Division. He suggested that a plate be installed beneath the oil tank sight gauges on trash packers to eliminate breakage. This is expected to save \$6,420 in the first year in costs for time and material. This is a partial award pending a final 12-month review. |
