Jan E. Johnson	City Clerk	\$285	Ms. Johnson is an Intermediate Typist. She suggested that Notices of Public Hearing be revised to eliminate the need for stapling. This is expected to save \$945 in the first year in labor costs.
Lawrence H. McGlone	Police	\$ 275	Mr. McGlone is a Dispatcher in the Communications Division. One year ago he earned a partial award of \$260 for his suggestion to adjust the computer printer to print more incidents per page. One year's experience has shown a savings of \$1,788. This is the remainder of his award.
Terrylynn Bolton	Risk Management	\$ 265	Ms. Bolton is an Intermediate Typist. One year ago she earned a partial award of \$260 for her suggestion to revise the procedure for notifying responsible parties in recovery actions. One year's experience has shown a savings of \$1,751. This is the remainder of her award.
Ed Doherty Jack A. Mead	Park & Recreation	\$ 200	Mr. Doherty and Mr. Mead are Equipment Technicians in the Central Division. One year ago they earned an intangible award of \$200 for their suggestion to hydrostatically test the tubes in the heat exchanger at Mission Beach Plunge. The hydrostatic tester has proven to be a valuable asset to the department and, therefore, the Committee approved an additional intangible award.
