Michael A. Gomez	Risk Management	\$ 180	Mr. Gomez is a Claims Representative II in the Public Liability Section. He suggested that a form letter be used for the rejection of Public Liability Claims. This is expected to save \$598 in the first year in labor costs.
Roy O. Miles	General Services	\$ 145	Mr. Miles is a Carpenter in the Buildings Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to use West System epoxy and fiberglass cloth on exterior wooden construction. One year's experience has shown a savings of \$1,448. This is the remainder of his award.
Terrylynn Bolton	Risk Management	\$ 130	Ms. Bolton is an Intermediate Typist. One year ago she earned a partial award of \$120 for her suggestion to combine Claims Recovery contact letters. One year's experience has shown a savings of \$835. This is the remainder of her award.
Ross A. Kerns	General Services	\$ 75	Mr. Kerns is a Roofer in the Buildings Division. He suggested that the heating system for the roofing kettle be updated. This is expected to save \$244 in the first year in labor costs.
