Iris E. Price	Personnel	\$ 75	Ms. Price is an Intermediate Clerk. She suggested that the job application bins be labeled with distribution instructions. Although savings were difficult to identify, this was considered to be a significant operational improvement.
William H. Campbell	Police	\$ 50	Mr. Campbell is a Police Sergeant. He suggested that the City use anti-graffiti paint on City buildings. The Buildings Division tested the paint on one restroom and found it to be effective. The Division plans more use of the product as the budget permits.
Robert L. Davis	General Services	\$ 30	Mr. Davis is a Plumber in the Buildings Division. One year ago he earned a partial award of \$75 for his suggestion to install a time clock on the heating system at the House of Hospitality. One year's experience has shown a savings of \$345. This is the remainder of his award.
Frank A. Hernandez	General Services	\$ 25	Mr. Hernandez is a Building Services Technician in the Buildings Division. He suggested that the elevators in the City Administration and Operations Buildings be labeled with identifying numbers. Although savings were difficult to identify, this was considered to be a significant operational improvement.
