BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

AERO DRIVE DRAIN REPLACEMENT.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$25,000.00 within the Capital Outlay Fund 30245 from CIP 12-040, San Diego River Basin-Flood Warning System and \$23,000.00 from CIP 58-004, Miscellaneous Improvements on City Streets to CIP 17-001, Minor Drain Improvements.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$80,000.00 from Capital Outlay Fund 30245, CIP 17-001, Minor Drain Improvements of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
