APPROVING MAP OF PARKSIDE TERRACES

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by GLENN R. FERGUSON, a Licensed Land Surveyor, entitled "PARKSIDE TERRACES Being a subdivision of Lot 167 of Bay Terraces Unit No. 3, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6624, filed in the office of the County Recorder of San Diego County, April 15, 1970.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Parkside Place, and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Parkside Avenue, adjacent and contiguous to Lots 6 and 7, all as shown on this map within this subdivision.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and said public street is accepted on behalf of the public as heretofore stated;

and that those certain abutters' rights of access as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
