
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those three street and drainage easement deeds of CROW CENTRAL FEDERAL #1, a Texas limited partnership, executed in favor of The City of San Diego, bearing dates of December 15, 1981, and March 18, 1982, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 256317-1, No. RR- 256317-2 and No. RR- 256317-3, granting to said City easements for street and drainage purposes over, under, along and across that portion of Parcel 1 of Parcel Map No. 11279, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named SKY PARK COURT.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
