RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO REQUESTING CALTRANS TO CONDUCT A DESIGN STUDY FOR THE INTERCHANGE OF INTERSTATE 805 AT NOBEL DRIVE.

WHEREAS, the California Department of Transportation (CALTRANS) has promulgated procedures for initiating interstate highway design feasibility studies; and

WHEREAS, CALTRANS' procedures require a minimum deposit of \$10,000 and a resolution of a local governmental agency indicating a desire to conduct the study; and


WHEREAS, Harry L. Summers, Inc., the developer of a project which would benefit from an interchange at Interstate 805 and Nobel Drive, has by letter of February 22, 1982 forwarded \$10,000 to the City for this purpose; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council of the City of San Diego hereby requests CALTRANS to prepare a project authorization report and to conduct a design study for the construction of a new interchange at Interstate 805 and Nobel Drive.

BE IT FURTHER RESOLVED, that the City Manager is authorized to accept the \$10,000 from Harry L. Summers, Inc., and to

forward such funds to CALTRANS for the purpose of conducting the design study for the interchange.
