BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the City Manager and the Planning Director are hereby authorized and directed to develop procedures and standards which will provide for consideration of energy conservation, energy efficiency and solar site planning measures in development approvals by the City.

BE IT FURTHER RESOLVED, that the City Manager and the Planning Director are hereby authorized and directed to develop a process which will protect solar access, in appropriate circumstances, within newly developing areas of the City.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$18,000 from the General Fund Unallocated Reserve to Planning Department Fund 06500 for the purpose of developing methods and procedures for implementing these actions.


