RESOLUTION NUMBER R- 256338

Adopted on MAY 4 1982

WHEREAS, JAMES RODNEY YOUNGSON appealed the decision of the Planning Commission in approving Preliminary Parcel Map PM-02-278-0, which proposes a two-parcel map of Lot 67 and portions of Lots 69 and 70, La Jolla Hills, Map-1479, located on Hillside Drive between Castellana Road and Via Siena in the R-1-8 Zone and within the boundaries of the La Jolla Community Plan; and

WHEREAS, on April 1, 1982, the Planning Commission voted to approve the map and uphold the decision of the Subdivision Board; and

WHEREAS, on April 9, 1982, pursuant to the provisions of Section 102.0203 of the San Diego Municipal Code, JAMES RODNEY YOUNGSON appealed the decision of the Planning Commission; and

WHEREAS, said appeal was set for public hearing on May 4, 1982, and testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; and


WHEREAS, the City Council, in considering said appeal is empowered by the provisions of Municipal Code, Section 102.0203, to affirm, reverse or modify, in whole or in part, any determination of the Planning Commission, subject to the limitations as are placed upon the Planning Commission by the Municipal Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,

that the appeal of JAMES RODNEY YOUNGSON is hereby denied, the decision of the Planning Commission is sustained and Preliminary Parcel Map PM-02-278-0 is hereby granted.
