
BE IT RESOLVED, by the Council of The City of San Diego as follows:

AND ITS ATTORNEY McINNIS, FITZGERALD, REES, SHARKEY & McINTYRE; and one check in the amount of \$2,949.60 made payable to TOPPER, LASRY & TOPPER, A GENERAL PARTNERSHIP, AND THEIR ATTORNEY McINNIS, FITZGERALD, REES, SHARKEY & McINTYRE, in full settlement of the lawsuit and of all claims.
