BE IT RESOLVED, by the Council of The City of San Diego as follows:

WHEREAS, by Resolution No. R-253980 the City Attorney was authorized to hire Leighton and Associates as an expert witness and consultant in connection with the Summit Ridge landslide litigation in an amount not to exceed \$25,000;

WHEREAS, unforeseen and unavoidable subsoil conditions have caused Leighton & Associates to incur additional costs and expenses not originally anticipated;

BE IT RESOLVED that the City Attorney is authorized to pay Leighton & Associates an amount not to exceed \$15,000, in addition to the amount authorized by Resolution No. R-253980, for services rendered in connection with the Summit Ridge landslide litigation;

BE IT FURTHER RESOLVED that the expenditure of an amount not to exceed \$15,000 from the General Fund Unallocated Reserve is authorized for the above purposes.
