

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Third Amendment to Agreement with STONE AND YOUNGBERG, for the purpose of amending the Agreement for the purchase of bonds for Sunset Cliffs Stabilization Assessment District Project, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- **256343**.

BE IT FURTHER RESOLVED, that the transfer within the Capital Outlay Fund 30245 of \$662,000 from CIP 52-103.1, Pomerado Road - Interstate 15 to 300 feet easterly of Scripps Ranch Boulevard, and \$402,658 from CIP 90-245, Capital Outlay Fund Reserve, to CIP 13-002, Sunset Cliffs Beach Erosion Control Project to be held in reserve for the repurchase of the Sunset Cliffs San Diego Improvement Bonds is hereby authorized.
