BE IT RESOLVED, by the Council of The City of San Diego as follows:


That Change Order No. 6, dated March 29, 1982, heretofore filed with the City Clerk of said City as Document No. RR- 256359, issued in connection with the contract between The City of San Diego and DVY CONSTRUCTION COMPANY for the Point Loma Wastewater Treatment Facilities Accelerated Projects, Construction Contract C-5, Schedule B: Digester Structural Improvements, said contract having been filed in the office of the City Clerk as Document No. A-00152, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$264,247, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$250,000 within Sewer Revenue Fund (41506) from the Unallocated Reserve (70697) to Sewer Construction Outlay (70292) CIP 46-071.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$264,247 is hereby authorized from Sewer Revenue Fund

(41506) for the sole and exclusive purpose of providing funds
for this project.


