

RESOLUTION No. R- 256379 (R-82-1905)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to accept payment of \$4,849.00, payable in six equal monthly installments, together with interest at the rate of 15% per annum, calculated on unpaid principal balances, from Theodore A. Krauss and Janice L. Krauss resulting from the lawsuit entitled The City of San Diego, etc. v. Theodore A. Krauss, et al., Superior Court No. 477809.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to modify the original contract wherein Mr. Krauss purchased Lot 2, South San Diego Industrial Park (Document No. RR 766911) to extend all employment compliance dates by 18 months, provided only if Mr. Krauss shall meet employment levels of 60, 65 and 70 on the compliance dates as amended.
