BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

SAN VICENTE RESERVOIR PARKING LOT REHABILITATION.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP 73-231, San Vicente Reservoir Parking Lot Rehabilitation, to the FY 1982 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$61,600.00 within Water Revenue Fund 41502 from CIP 73-230, Various Lakes - Docks to CIP 73-231, San Vicente Reservoir Parking Lot Rehabilitation.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$61,600.00 from Water Revenue Fund 41502 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
