- 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$25,000 from the General Fund 100, Fire Department (120), Object Account 6010, Job Order 673500, and \$20,000 from Fire Department (120), Object Account 6010, Job Order 130001 to Capital Outlay fund 30245, CIP 33-073, Fire Repair Facility No. 1-Truck Hoist.
