A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM BY AMENDING DOCUMENT NO. 00-15552-1, AS AMENDED, BY ADDING PROJECT NO. 33-073, ENTITLED "FIRE REPAIR FACILITY NO. 1-TRUCK HOIST," TO THE 1982 CAPITAL IMPROVEMENT PROGRAM, AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$25,000 FROM THE GENERAL FUND 100, FIRE DEPARTMENT (120), OBJECT ACCOUNT 6010, JOB ORDER 673500, AND \$20,000 FROM FIRE DEPARTMENT (120), OBJECT ACCOUNT 6010, JOB ORDER 130001 TO CAPITAL OUTLAY FUND 30245, CIP 33-073, FIRE REPAIR FACILITY NO. 1-TRUCK HOIST.


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 2, subsection 30 of the Annual Appropriation Ordinance, the Capital Improvements Program as contained in Document No. 00-15552-1, as amended, be and the same is hereby further amended by adding Project No. 33-073, entitled "Fire Repair Facility No. 1-Truck Hoist," to the fiscal year 1982 CIP Program.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$25,000 from the General Fund 100, Fire Department (120), Object Account 6010, Job Order 673500, and \$20,000 from Fire Department (120), Object Account 6010, Job Order 130001 to Capital Outlay fund 30245, CIP 33-073, Fire Repair Facility No. 1-Truck Hoist.
