
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of WILLIAM A. TOTH, a married man, JOHN D. GRAY, a married man, and SIMCO, a partnership composed of NANCY SIMONS, et al.; and BULLUM, LTD., a limited partnership, executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 256390 - 1 and No. RR- 256390 - 2, granting to said City easements for street and drainage purposes in portions of Lot A-154 of Addition No. 1 to San Ysidro, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and Parcel 1 is hereby named LOUISIANA AVENUE, and Parcel 2 is hereby named BOLTON HALL ROAD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
