BE IT RESOLVED, by the Council of The City of San Diego, that the City Attorney is hereby authorized to officially notify Book Publishing Company that the City does not intend to proceed further with the contract for recodification of the San Diego Municipal Code.

BE IT FURTHER RESOLVED, that the City Attorney and City Clerk are hereby directed to work with the San Diego Data Processing Corporation to undertake a joint effort to computerize the San Diego Municipal Code, using the Legislative Information System (LEGIS), a software program presently used by the City Clerk, City Attorney and City Manager.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer the sum of \$25,000 from Allocated Reserve Fund 10001, Project No. 250316 and \$15,000 from City Clerk Department 0350 from Programs 03530 (\$9,000) and 03540 (\$6,000) to the Allocated Reserve Fund 10001 (project number to be assigned), solely and exclusively to provide funds for the above purpose.
