BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the Purchasing Agent of the City of San Diego be and he is hereby authorized and directed to advertise for sealed bids for furnishing OCEAN OUTFALL INTAKE/POWER PLANT BYPASS THROTTLING AND SHUTOFF VALVES in accordance with specifications, bidding instructions and requirements on file in the office of the City Clerk bearing Document No. RP-256405
2. BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for OCEAN OUTFALL INTAKE/POWER PLANT BYPASS THROTTLING AND SHUTOFF VALVES.
3. BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$295,000.00 from Sewer Revenue Fund 41506 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
