

RESOLUTION NUMBER R- **256410**

Adopted on MAY 17 1982

WHEREAS, on December 15, 1981, this Council approved the plans and specifications bearing Official Document No. A-00280 for the CONSTRUCTION OF ALLIED GARDENS SWIMMING POOL LANDSCAPING and authorized the expenditure of \$148,150.00 from CIP 23-255 for this project; and

WHEREAS, bids for this work were opened on January 15, 1982; and

WHEREAS, a protest from one of the bidders identified an irregularity involving the apparent low bid; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That all bids heretofore received on January 15, 1982 pursuant to publication of notice calling for bids on CONSTRUCTION OF ALLIED GARDENS SWIMMING POOL LANDSCAPING, San Diego, California, are hereby rejected.



reliable bidder for CONSTRUCTION OF ALLIED GARDENS SWIMMING POOL
