RESOLUTION NUMBER R-256412 Adopted on MAY 17 1982

WHEREAS, the County of San Diego has proposed to locate a County Mental Health Facility in the vicinity of 45th Street and Imperial Avenue in the City of San Diego; and

WHEREAS, the potential impacts of such proposed facility would be inconsistent with the commitment of resources by the City of San Diego to the economic revitalization of the local community and improvement of its tax base through the efforts of the Southeast Economic Development Corporation; and

WHEREAS, local community residents have expressed strong opposition to the location of the proposed facility at the Imperial Avenue site; and

WHEREAS, the City's Planning Department staff has conducted a preliminary review of the proposed use at the Imperial Avenue site and concluded that it would create a negative impact on the community; and

WHEREAS, suitable alternative sites are available which, in the opinion of Planning Department staff, would not adversely impact the surrounding community; and

WHEREAS, the matter was considered by the San Diego County Board of Supervisors on May 11, 1982 and continued for further study, until June 15, 1982; and

WHEREAS, the decision of the Board is of extreme importance to the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that it directs the City Manager, Planning Department, and the Southeast Economic Development Corporation to conduct a study, in cooperation with County staff, of the planning and cost benefits of the County proposal to utilize this site and, to aid in the search for and evaluation of alternate site.

BE IT FURTHER RESOLVED, that the Council strongly recommends that the Board of Supervisors evaluate the findings of the aforementioned study prior to making a decision as to siting the facility at the proposed site.
