

INC., a corporation, for the CONSTRUCTION OF SOUTHCREST PARK & RECREATION CENTER BALLFIELD AND CHANNEL FENCING, HOLLYWOOD PARK FENCING AND COLINA DEL SOL PARK BOCCI COURT FENCING, Schedules 1, 2 and 3, and Additive Alternates 1, 2 and 3 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00292.
