BE IT RESOLVED, by the Council of The City of San Diego, as follows:



2. That the bid of \$2,309,934.00 by D & H PERRY INC., dba PERRY ELECTRIC, a corporation, for the INSTALLATION OF MASTER TRAFFIC CONTROL SYSTEM CENTRAL BUSINESS DISTRICT in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk.


