
Adopted on MAY 25 1982

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street easement deeds of ALFRED M. LEWIS PROPERTIES, INC., a California corporation, and LNC/GENTRY, a partnership, executed in favor of The City of San Diego, bearing dates of March 11, 1982, and February 2, 1982, respectively, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 256439 - 1 and No. RR- 256439 - 2, granting to said City easements for public street purposes over, along and across a portion of Lot 1 of Alfred M. Lewis Distribution Center, Unit No. 1, Map No. 7184, and a portion of the East Half of the Southeast Quarter of Section 2, Township 15 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named TRADE PLACE, and TRADE STREET.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
