BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to do by City Forces all the work to cut and plug the existing twelve-inch water main in Ocean View Boulevard, at 42nd Street location and subsequently reconnect after proposed new bridge over South Las Chollas Creek is completed; and Hi-line same twelve-inch main and reinstall at a lower elevation to clear sewer main construction at San Pasqual Street location, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$11,500.00.

BE IT FURTHER RESOLVED, that the expenditure of \$11,500 from the previously authorized \$233,560 Fund/Dept. 18517/5988, Org. 8817, contingencies to be paid to Utilities Department is hereby authorized.
