Russel Bye	Park & Recreation	\$1,000	Mr. Bye was a Heavy Truck Driver in the Coastal Division. He suggested that the hinges on the beach truck tail gates be modified to enable crews to haul and dump larger loads of beach kelp. This modification has saved the City \$31,214 in the first year of use in costs for labor and equipment rental. This is a full award.
Dennis L. Marnell	General Services	\$ 795	Mr. Marnell is an Equipment Mechanic in the Equipment Division. One year ago he earned a partial award of \$790 for his suggestion to relocate the forward limit switches on refuse packers. One year's experience has shown a savings of \$5,466. This is the remainder of his award.
