<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Robert L. Davis	General Services	\$430	Mr. Davis is a Plumber in the Buildings Division. One year ago he earned a partial award of \$210 for his suggestion to install a flow switch in the water make-up line to the boiler at the Fine Arts Gallery. One year's experience has shown a savings of \$2,130. This is the remainder of his award.
Thomas R. Clark	Fire	\$360	Mr. Clark is a Fire Captain. One year ago he earned a partial award of \$280 for his suggestion to have uniformed personnel perform annual pump service tests. One year's experience has shown a savings of \$2,137. This is the remainder of his award.
Ty S. Reid	Police	\$250	Mr. Reid is a Police Sergeant. He suggested that the department utilize an automatic telephone answering device to notify officers of court continuances and cancellations. This is expected to save over \$19,000 in the first year in costs for overtime paid for unnecessary court appearances. This is a partial award pending a final 12-month review.
Iris E. Price	Personnel	\$220	Ms. Price is an Intermediate Clerk. She suggested that repetitious job announcements for promotional series examinations be discontinued. This is expected to save \$731 in the first year in time and material costs.
