WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Ralph Yturralde	Property	\$205	Mr. Yturralde was an Equipment Technician at Mt. Hope Cemetery. He suggested that the lawn mowing equipment be modified to simplify the adjustment of the drive chains. This is expected to save \$681 in the first year in costs for time, material and equipment.
Mary H. Middendorf	Water Utilities	\$195	Ms. Middendorf is an Assistant Chemist in the Water Quality Division. One year ago she earned a partial award of \$190 for her suggestion to use a programmable calculator to prepare reports, calculate calibration curves, and determine sample concentrations during analysis. One year's experience has shown a savings of \$1,291. This is the remainder of her award.
Ronald E. Keith	Fire	\$180	Mr. Keith is a Fire Fighter. He suggested that the automatic door controllers be wired directly to the batteries on the fire apparatuses. This is expected to save \$1,181 in the first year in repairs to transmitters and battery replacement. This is a partial award pending a final 12-month review.
George R. Ikeda	General Services	\$135	Mr. Ikeda is a Carpenter in the Buildings Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to turn off furnace pilot lights during summer months. One year's experience has shown a savings of \$456. This is the remainder of his award.
