WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Robert L. Davis	General Services	\$105	Mr. Davis is a Plumber in the Buildings Division. He suggested that a one-hour timer be installed on the restroom heater in Building 41 at the Central Operations Station. This is expected to save \$356 in the first year in gas and electric costs.
John M. Whyte	Fire	\$ 50	Mr. Whyte is a Fire Captain. He suggested that equipment for reserve apparatuses be stored in crates in the assigned fire station. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Barbara A. Bahde	Library	\$ 50	Ms. Bahde is an Intermediate Typist. She suggested that a form printed on NCR paper be used to coordinate records of periodical volumes sent to the bindery. This is expected to save \$161 in the first year in labor costs.
Russell W. Lougy	Fire	\$ 25	Mr. Lougy is a Fire Captain. He suggested that a different type sprayer be used to spray "Smoke-0" at small fires. Although savings were difficult to identify, this was considered to be a significant operational improvement.
