WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Thomas C. Thurber	General Services	\$25	Mr. Thurber is an Auto Messenger in the Buildings Division. He suggested that a wheeled map bin be constructed for the storage and transfer of bulky maps. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Edward J. Zitter	Police	\$25	Mr. Zitter is a Police Sergeant. He suggested that the Police Department establish a program to remind employees of the importance of vehicle safety. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Jacqueline S. Clayton	General Services	\$20	Ms. Clayton is an Auto Messenger in the Buildings Division. She suggested that the mail delivery route be modified to eliminate the need to take the mail cart over a set of steps. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Theresa L. Kernitzki	Building Inspection	\$15	Ms. Kernitzki is a Senior Typist. She suggested that the subscription fee for the Statistical Building Report be increased. This is expected to result in an increase in revenue of \$42 in the first year.
