BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. R. G. CABRAL TRUCKING and 2. HOFER AND JACOBS TRUCKING are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing HAULING OF DRIED SLUDGE ON FIESTA ISLAND as may be required for a period of one (1) year beginning July 1, 1982 through June 30, 1983 as follows:

1. R. G. CABRAL TRUCKING - Section A for hauling approximately 60,000 cubic yards of dried sludge on Fiesta Island at a cost of \$0.63 per cubic yard for a total estimated cost of \$37,800.00; terms net 30 days, with an option to renew contract for an additional one (1) year period at prices not to exceed 10% of bid price.
2. HOFER AND JACOBS TRUCKING - Section B for hauling approximately 20,000 cubic yards of dried sludge from Fiesta Island to Utilities property adjacent to Brown Field at a cost of \$2.19 per cubic yard for a total estimated cost of \$43,800.00; terms 2% 30 days, with an option to renew contract for an additional one (1) year period at prices not to exceed 10% of bid price.
