**BE IT RESOLVED**, by the Council of The City of San Diego as follows:

That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for

CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT AVENIDA DE LA PLAYA AND LA JOLLA SHORES DRIVE, BARNETT AVENUE AND LYTTON STREET, AND BUENOS AVENUE AND WEST MORENA BOULEVARD, San Diego, California

filed in the office of the City Clerk of the City of San Diego, California, on May 19, 1982, and bearing official Document No. W.O. 118114, be, and the same are hereby approved.

**BE IT FURTHER RESOLVED**, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

**BE IT FURTHER RESOLVED**, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

**BE IT FURTHER RESOLVED**, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT AVENIDA DE LA PLAYA AND LA JOLLA SHORES DRIVE, BARNETT AVENUE AND LYTTON STREET, AND BUENOS AVENUE AND WEST MORENA BOULEVARD.

**BE IT FURTHER RESOLVED**, that the City Auditor and Comptroller is hereby authorized to consolidate CIP No. 62-203, AVENIDA DE LA PLAYA AND LA JOLLA SHORES DRIVE and CIP No. 62-204, BARNETT AVENUE AND LYTTON STREET into CIP No. 62-215, BUENOS AVENUE AND WEST MORENA BOULEVARD.

**BE IT FURTHER RESOLVED**, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245, \$80,000.00 from CIP No. 62-203, AVENIDA DE LA PLAYA AND LA JOLLA SHORES DRIVE and \$80,000.00 from CIP No. 62-204, BARNETT AVENUE AND LYTTON STREET into CIP No. 62-215, BUENOS AVENUE AND WEST MORENA BOULEVARD.
