
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of funds in an amount not to exceed \$27,000 is hereby authorized from CIP 29-427, San Ysidro Community Park-Beautification and Rehabilitation, Park Service District, Fund 11741, solely and exclusively for this purpose.
