

SUBJECT: Unified Disaster Council

SUMMARY

Issue - Should the City rejoin the Unified Disaster Council?

Manager's Recommendation - The City should rejoin the Unified Disaster Council for FY 82 - 83 and budget funds for the membership fee.

Fiscal Impact - The membership fee for FY 82 - 83 will be \$53,000.

BACKGROUND

On April 5, 1982 Mr. Clifford Graves, Chief Administrative Officer, San Diego County, appeared before the Rules Committee to request that the City of San Diego rejoin the Unified Disaster Council, an advisory council to the San Diego County Board of Supervisors designed to coordinate disaster preparedness planning and response. The City had previously been a member of the Unified Disaster Council but had withdrawn during FY 81- 82 due to concerns that the Office of Disaster Preparedness was not providing the services which had been expected.

Information regarding specific concerns of City staff as well as a request for information were provided to Mr. Graves during the April 5, 1982 Rules committee meeting. He has responded to those concerns and provided the information requested. Due to the satisfactory response and the desire on the part of the City to cooperate and coordinate with all other cities in San Diego County and with the County of San Diego, it is recommended that the City rejoin the Unified Disaster Council in FY 82 - 83. Further it is recommended that \$53,000 be placed in the FY 82 - 83 budget under Emergency Management for the Unified Disaster Council membership fee.


