
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That BROWN AND NAZAREK, attorneys at law, be employed and appointed as special bond counsel for giving an opinion on any bonds that may be issued to pay for the financing and acquisition of certain undeveloped lands in the Otay Mesa Road area for the proposed OTAY MESA ROAD - HARVEST ROAD ASSESSMENT DISTRICT under the provisions of the Municipal Improvement Act of 1913, pursuant to the terms and conditions set forth in the Special Counsel Agreement on file in the office of the City Clerk as Document No. D2236-1.

2. That in the event the proposed proceedings fail to materialize or are abandoned before an assessment has been levied and collected, the City shall not be liable for any payment in excess of \$1500 for the costs incurred in said employment.

3. That the expenditure of \$1500 from CIP 58-002, Fund 30245, for the purpose of providing funds for the payment of special bond counsel is hereby authorized.
