BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to issue a Request for Proposals to provide consulting services for preparation of a master plan for an educational and cultural facility or facilities in the Barrio Logan/Harbor 101 community, the cost of which consultant services to not exceed \$48,000, a copy of which Request for Proposals is on file in the office of the City Clerk as Document No. RR- 256540 -/.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute an Agreement between the City, San Diego Community College District and the San Diego Unified School District, for the purpose of administering and paying for said consultant services, under the terms and conditions set forth in that Agreement on file in the office of the City Clerk as Document No. RR- 256540-2.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$18,000 from CDBG Fund 18516 is hereby authorized.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the amount of \$15,000 each from the San Diego Community College District and the San Diego Unified School District, to provide additional funds necessary for said consultant services pursuant to the above specified Agreement.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized and directed to establish a special fund and to place

into said special fund the \$18,000 City contribution and the two \$15,000 Community College District and School District contributions to be expended in accordance with the above specified Agreement.
