RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO CONSENTING TO AND CALLING A JOINT PUBLIC HEARING ON THE PROPOSED REDEVELOPMENT PLAN FOR THE GASLAMP QUARTER REDEVELOPMENT PROJECT AND THE FINAL EIR RELATING THERETO.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency"), by Resolution No. 763 on June 8, 1982, submitted to the City Council of The City of San Diego a proposed Redevelopment Plan (the "Redevelopment Plan") for the Gaslamp Quarter Redevelopment Project (the "Project") and consented to and requested that the City Council call a joint public hearing of the Agency and the City Council to consider and act upon the proposed Redevelopment Plan, together with a joint public hearing on the Final Environmental Impact Report for the Redevelopment Plan; and

WHEREAS, the City Council acknowledges the receipt of the proposed Redevelopment Plan, along with the Report to City Council and the Final Environmental Impact Report on the Redevelopment Plan; and

WHEREAS, Section 33355 of the California Community Redevelopment Law (Health and Safety Code Section 33000, et seq.) authorizes a joint public hearing on the proposed Redevelopment Plan with the consent of the Agency and the City Council; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of The City of San Diego, as follows:

1. The City Council hereby consents to and, at the request of the Agency, calls a joint public hearing of the Agency and the City Council on Tuesday, July 6, 1982, at 8:30 a.m. in the City Council Chambers to consider and act upon the proposed Redevelopment Plan and all documents and evidence pertaining thereto, together with a joint public hearing on the Final Environmental Impact Report for the Project.

2. The City Clerk of The City of San Diego shall, in cooperation with the Secretary of the Agency, prepare, publish and mail such notices and documents and do all other acts as may be necessary to carry out the purposes of this resolution.
