

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the offer of FMC FINANCE CORPORATION is hereby accepted and the City Manager is hereby authorized to execute a contract for the LEASE-PURCHASE OF ONE (1) EACH SENTRY 70-10 OPTICAL MARK READER AND ACCESSORIES for five (5) years beginning June 1, 1982 through May 31, 1987 at a total cost of \$82,988.40, to be paid in sixty (60) equal monthly payments of \$1,383.14 each; with an option to cancel due to lack of funds at the end of each fiscal year according to the terms of the agreement on file in the office of the City Clerk as Document No. RR- 256565.
