## RESOLUTION NUMBER R- 256585 Adopted on JUN 15 1982

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where for a period of five consecutive years the street to be vacated has been impassable for vehicular travel and during such period no public money has been expended for maintenance; and

WHEREAS, the abutting property owner has requested the vacation of that portion of Road Survey 466 in the Northeast 1/4 of the Southeast 1/4 of Section 10, S.B.M., all within the Carroll Ridge Unit 4 (TM 01-181) Subdivision boundaries to facilitate development of his property; and

WHEREAS, a portion of Road Survey 466 has been impassable for five consecutive years and no public money has been expended for maintenance; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Road Survey 466 in the Northeast 1/4 of the Southeast 1/4 of Section 10, S.B.M., all within the Carroll Ridge Unit 4 (TM 01-181) subdivision boundaries, as more particularly shown on Drawing No. 15626-B on file in the office of the City Clerk as Document No. RR- 256585-/ which is by this reference

incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that this resolution shall not become effective unless and until the Carroll Ridge Unit 4 Subdivision map, subdividing the land adjacent to the right-of-way, has been approved by Council action. In the event that the above condition cannot be met, this resolution shall become void and of no further effect.

BE IT FURTHER RESOLVED, that the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this Resolution, attested by him under seal, to be recorded in the office of the County Recorder.


