WHEREAS, the U.S. Supreme Court rendered a decision in the case of Community Communications Co. v. City of Boulder creating prospective liability under federal antitrust laws; and

WHEREAS, in order to reduce municipal liability and alleviate adverse impacts resulting from said decision, it is proposed that amendments to such federal law be enacted; and

WHEREAS, the City Attorney, in cooperation with the City
Attorney of San Jose, has drafted proposed amendatory language
to the antitrust laws, which is intended to significantly lessen
the City's vulnerability to antitrust claims; and

WHEREAS, these efforts have been closely coordinated with the National League of Cities, U. S. Conference of Mayors, and the City's Department of Intergovernmental Relations; and

WHEREAS, it is recommended that the Council indicate its support of these proposed amendments and add them to the City's legislative program; and

WHEREAS, it is further recommended that the City Attorney travel to Washington, D. C. during the period June 27 - July 1, 1982 to acquaint appropriate officials with the City's position and to attend hearings on the proposed amendments scheduled for June 30, 1982; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that legislative amendments to federal antitrust laws (Title 15, U. S. Code) proposed by the City Attorney be, and the same are hereby approved and adopted.
