
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of (1) GENERAL ELECTRIC SUPPLY CO. and (2) GRAYBAR ELECTRIC COMPANY, INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of DRY CELL BATTERIES as may be required for the period of one (1) year beginning July 1, 1982 through June 30, 1983, per prices on file in the Purchasing Department, as follows:

- (1) GENERAL ELECTRIC SUPPLY CO. for Section I, (flashlight batteries, sizes D, C, AA, and 9-volt transistor batteries); terms net 30 days plus sales tax, with option to renew contract for an additional one (1) year period; and
- (2) GRAYBAR ELECTRIC COMPANY, INC., for Section II, (6-volt lantern batteries), and III, (other carbon zinc, alkaline and mercury batteries); terms 2% 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period.
