BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the addition of CIP 53-035, Ingraham Street Bridge over Mission Bay Channel to FY 82 Capital Outlay Improvement Program is hereby authorized.

That the City Auditor and Comptroller be and he is hereby authorized to transfer \$40,000 from CIP 90-245, Capital Outlay Reserve Fund 30245, to CIP 53-035, Ingraham Street Bridge over Mission Bay Channel.

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with McDaniel Engineering Company to provide environmental documents for the Ingraham Street Bridge over Mission Bay Channel, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 256612.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$40,000 from CIP 53-035, Ingraham Street Bridge over Mission Bay Channel, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
