Norval L. Brewer	Fire	\$ 3,075	Mr. Brewer was a Battalion Chief at the time he submitted this suggestion. One year ago he earned a partial award of a Certificate of Merit for his suggestion to make minor variations in the specifications for turnout clothing to allow for more competitive bidding. One year's experience has shown a savings of \$10,248. This is the remainder of his award.
John C. Kersell Richard A. Creighton	General Services	\$ 2,120	Mr. Kersell and Mr. Creighton are Equipment Mechanics in the Equipment Division. They suggested that the ends of the augers on the beach screens be extended to prevent premature damage to the screens. This is expected to save \$7,072 in the first year in labor and material costs.
Michael D. Eacobellis	General Services	\$ 1,405	Mr. Eacobellis is an Equipment Mechanic in the Equipment Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to install water separator type fuel filters on diesel engine beach equipment. One year's experience has shown a savings of \$4,688. This is the remainder of his award.
